#### **Cancellations and Refunds:**

You may withdraw from an individual course or the Full Certificate Program. Notice of withdrawal must be submitted in writing via email to [tameka.chatman@rutgers.edu](mailto:tameka.chatman@rutgers.edu).

Withdrawal from individual courses must be submitted in writing via email to [tameka.chatman@rutgers.edu](mailto:tameka.chatman@rutgers.edu) no less than three (3) full business days before the first class session begins in order to receive a full refund, less a \$50.00 processing fee. If you do not notify us in writing at least three (3) business days prior to the start of the first class session, you will not receive any refund but, in lieu of a refund, you may request a credit towards a future course offered by the Juvenile Justice and Youth Development Certificate Program, which must be used within 12 months after issue date.

#### **Withdrawal from the Full Certificate Program:**

You may withdraw from the Full Certificate Program in writing via email to [tameka.chatman@rutgers.edu](mailto:tameka.chatman@rutgers.edu) no less than seven (7) full business days after purchase to receive a full refund, less a \$50 processing fee. If you do not notify us in writing at least seven (7) days after purchase, you will be responsible for the full fee. There is no future credit option in the event you cancel a Full Certificate Program purchase.

#### **Refund Process:**

Credit Card Payments: a refund will be issued back to the same credit card. Check, Cash, or Money Order Payments: a refund will be issued by check to the individual/entity who made the original payment. Please allow up to eight weeks to receive your refund.
